Also removed a 30 ft stalk growing out of the Century plant that would have eventually toppled over onto either lane.

The crew will come back after 3 weeks to take out the Century plant and touch up any trimming on the Wilmot entry and spray any new weeds that may have popped up.

The County has yet to seal and patch the cracks on Girasol after it was requested back in January.
