See profit and loss budget performance file to date. We are running on track as expected for income.

Still have one outstanding dues not paid. Owner is on a payment plan. Concern about 10% monthly late fee. Research is needed to confirm an appropriate amount (reasonable/acceptable.) Owner wants to set up a payment plan for 2019 and is hoping to add previous owed balance from 2018 to pay off the debt. Owner is paying as arranged.

In February Bob Linsell made a motion for 2019 onward that we charge a 24% APR late fee on the existing balance and a \$15 per month bookkeeping fee. Motion passed

Question about late fees notification. We will post the late fee amounts on the website.

Question about liens as possible for getting annual dues payment. Will speak with a lawyer for details.

Cost of January annual board meeting is estimated as under budget. Surplus will be used for monthly board meeting room rentals.

Long term rental fee of \$25 is to be paid per tenant. Francis Morgan will put together step by step instructions for Pat to monitor for rentals monthly.

Lot 91 homeowner will pay monthly payment of \$50. Omar Candelaria made a motion to allow payment plan Mike Carsten is seconded it. Motion passed
