Per the city of Tucson there are regulations on political signs. Will send out guidelines via email. Will ask Francis Morgan if we can send it to the neighborhood. Bob Linsell will put together the letter.

Real Estate signs are the only other signs allowed per our HOA.

Lot 194 Disabled truck in driveway: Notice of hearing letter was sent because it's in violation of CR and Rs. Bob Linsell spoke with the homeowner. He has put air in the tires of the disabled truck but the vehicle still isn't registered with the city. The homeowner is now non responsive. Motion to fine (\$100) the homeowner and a request to attend a meeting. He did not attend. So now we will send another letter requesting attendance for the purpose of fining him another \$100. Process continues if the homeowner doesn't attend. If the issues are not resolved the board will follow the guidelines set by the bylaws.
